Complaint on Meet Me At the Fence Facebook Group

The Cards for Kids Act applies to children within Canton Union School District ages 3 through grade 12. While the Parlin-Ingersoll Public Library gives cards to children at age 3, many other libraries do not issue cards until children are older. Kewanee, Illinois Prairie (Metamora), and Fondulac (East Peoria) issue cards at age 5. Washington issues cards at age 4. Both Alpha Park (Bartonville) and Pekin issue cards to children under age 14 when accompanied by a parent. Peoria Public will issue cards at birth to City residents.
